Eligibility

- Former Ross County, Ohio, 4-H Member
- Age 19 or older as of January 1, 2021
- Freshman, Sophomore, Junior or Senior status at any accredited college, university, or technical school
- Enrolled as a full-time student (minimum of 12 credit hours)
- Undergraduate cumulative GPA of 2.5 or better
- Any academic major acceptable

Selection Criteria

- 30% 4-H Experiences & Activities
- 45% 4-H Alumni Experiences & Activities
- 15% Financial Need
- 10% Essay Question (Future Plans/Impact of 4-H)

Ross County Barn Superintendent Memorial Scholarship

\$1000 - Families of Barn Superintendents Funded

Eligibility

In addition to Ross County 4-H Scholarship eligibility requirements:

- Former Ross County 4-H/FFA participant for a minimum of 5 years
- Completed a Ross County 4-H/FFA animal project (any animal) for a minimum of 3 years

Selection Criteria

- 50% 4-H Experiences & Activities
- 25% Financial Need
- 25% Essay Question (same as other)

Application Procedure

- Application must be **TYPED in ARIAL 11 point font**
- Submit with Application
 - Copy of current college/university transcript or grade report
 - Letter of Recommendation from an academic advisor or professor
 - Staple all pages/materials together in top left-hand corner. Do not use tabbed dividers, cover sheets, or any type of folder/binder
